Registration Information & Procedures

Please complete and return this registration form with a **NON-REFUNDABLE, NON-TRANSFERABLE** deposit of \$200 per student, payable to the Winnipeg Board of Jewish Education, no later than March 4, 2011 in order to guarantee your child a space. Registration will not be considered complete unless this form is signed and accompanied by a deposit cheque. Post-dated deposit cheques cannot be dated later than March 4, 2011. The number of students registered by 4:30 p.m. March 4, 2011 will determine the number of classes or sections per grade. Applications received after March 4, 2011 are NOT guaranteed placement, and may be placed on a waiting list.

Please refer to the 2011/12 Parental Guideline. If your family falls into the category of being a full contribution family, a statement and payment form will be mailed to you upon receipt of the registration form and deposit.

If your family is eligible for assessment (this applies to students in K-Grade 12 only), please complete the Supplementary Financial Information Form and return it along with the financial registration form and deposit cheque. If your financial information is not available by March 4, 2011, please send in your financial registration form and deposit cheque. You may submit the Supplementary Financial Information Form at a later date. You may be asked to meet with the Chief Financial Officer to review or verify your financial information. After reviewing your financial information, your parental contribution will be set per the parental contribution guidelines and a statement and payment form will be mailed to you. **All information is treated in the strictest confidence. Please note: Ability to contribute is based on a number of financial parameters and considerations which include income, expenses, assets, liabilities and other information as may be determined by the Assessment Committee.**

PAYMENTS – Payment forms must be deposited at the Registrar’s office by August 5, 2011. Parental contributions may be paid by cash, pre-authorized payments (automatic debit), Visa or MasterCard. A discount of 1.5% will be applied to the parental contribution if the amount is paid in full by the first day of school by cash or cheque.

Pre-authorized payments (automatic debit) – A series of ten monthly payments can be automatically debited to your bank account.

Returned cheques – Parental accounts will be charged a \$25 administration fee for all payments rejected by the bank.

Visa or MasterCard credit card payment is accepted if the parental contribution is paid in full by the first day of school. **Monthly credit card payments are not accepted.**

WITHDRAWALS – Students withdrawn will be charged a \$200 withdrawal fee. In addition, if a student attends classes in any portion of a month, a full month’s fee will be charged for that month.

TAX DEDUCTIBILITY – In accordance with Revenue Canada Information Circular 75-23, parental contributions for students in Kindergarten – Grade 12 may qualify as a charitable donation on your income tax return. The JK payment may qualify as a child care expense on your income tax return.

I HAVE READ AND ACCEPT THE CONDITIONS ABOVE for registration and understand that failure to abide by them may result in termination of the student’s enrolment.
